D. Results of Lewisville's Participation in the Denton County Health Coalition:

Dr. Joseph Walker, Assistant Professor at The University of North Texas, was our guest speaker at the meeting this evening. His presentation was "Measuring Park Use for Physical Activity and Healthy Living related Issues." The City of Lewisville Parks and Leisure Services Department is a participating member of the Denton County Health Coalition. UNT Recently conducted a phone survey of randomly selected Lewisville residents to measure overall health issues, eating habits, participation in physical activity, park use and knowledge of city programs. Questions asked were designed to collect the same data that the Centers of Disease Control Behavioral Risk Factor Surveillance System (BRFSS) collect. BRFSS has been collecting and tracking health condition data since 1984. The objective of this survey is to use baseline data to follow the effectiveness of future programs designed to improve healthy behaviors.

E. Reports


