The proposed residential development consists of 27 condominium units on one lot as illustrated on the attached concept plan. This type of development is similar to other nearby developments, including Victoria Heights and Villas on Rockbrook, in that the detached units appear as single family detached homes. This allows for individual ownership or renting of a detached unit. Three variances are requested: a) to waive the requirement to convey existing drainage with less than 200 cfs. in a closed system; b) to waive the requirement to construct a right turn lane at the intersection of Rockbrook and Oak Bend; and c) to waive the requirement for screening walls. The development supports Big Move Number 5: New Neighborhood Choices from the Lewisville 2025 Plan. The Planning and Zoning Commission recommended unanimous approval (6 0) of the zone change on September 18, 2018.

The City staff's recommendation was that the City Council approve the ordinance and the three associated variances as set forth in the caption above.

Texas Local Government Code Chapter 395 requires a political subdivision imposing an impact fee to review and evaluate the Capital Improvements Plan every five years. A public hearing and the first of three readings of this ordinance took place at the September 17, 2018 City Council meeting. The second reading took place at the October 1, 2018 City Council meeting. The proposed ordinance sets Capital Recovery (Impact) fees of \$2,614.00 per living unit equivalency for water, and \$2,724.00 per living unit equivalency for wastewater.

The City staff’s recommendation was that the City Council conduct the third and final reading of the ordinance as set forth in the caption above.

City Council approved a resolution on April 2, 2007 authorizing the creation of Lewisville Castle Hills Public Improvement District (PID) No. 4. On May 21, 2007, a Service and Assessment Plan and Assessment Roll was adopted. On May 19, 2014 a public hearing was held and an amended and supplemental plan was adopted for development changes due to lots being subdivided into different sizes that had not originally been anticipated in the original Service and Assessment Plan. This item is an update and identifies final public improvement costs provided by the PID and reflects all assessments and annual installments as now being paid in as well as reporting related information. PID No. 4 encompasses the same area as Denton County Fresh Water Supply District (DCFWS) 1 F.

The City staff's recommendation was that the City Council approve the ordinance as set forth in the caption above.

On September 24, 2018 staff received a letter outlining a future potential sale and assignment of the current City of Lewisville contract and exclusive franchise for collection of residential garbage, refuse, yard waste, bulky waste, recyclables, containerized waste and multifamily recycling with Waste Management of Texas, Inc. to Allied Waste Systems, Inc. (Republic). Republic will assume all terms and conditions of the existing contract with the City. It is anticipated that this transaction will take place on or around October 31, 2018.

The City staff's recommendation was that the City Council approve the request as set forth in the caption above.

City Manager Barron addressed the City Council regarding this item. She acknowledged the quality service that Waste Management has provided over the years.

At the request of City Manager Barron, Eric Ferris, Deputy City Manager, reviewed information contained in the City staff memo for City Council regarding this item. He assured the City Council that there should not be any changes to residents' current service.

Consideration of a Request for an Assignment and Assumption of Contract Related to the City's Current Contract and Exclusive Franchise for Collection of Residential Garbage, Refuse, Yard Waste, Bulky Waste, Recyclables, Containerized Waste and Multifamily Recycling with Waste Management of Texas, Inc. to Allied Waste Systems, Inc. (cont'd)

(Agenda Item H-15)

At the request of Deputy City Manager Ferris, Steve Keller with Waste Management spoke before the City Council regarding this change. He acknowledged City staff for the outstanding service and continuity and years of knowledge they have provided. He assured the citizen's that it should pretty much be the same people providing service after the change, that have provided service during Waste Management's tenure. He further explained that this was merely a business decision, nothing more.

Brady Lesh from Republic spoke before the City Council regarding this change and expressed their excitement to provide service to the City of Lewisville. He stated that they do not anticipate any changes to service and they expect to hire as many of the Waste Management employees that they are able. Information material from Republic was submitted to the City Council from a representative of Republic.

MOTION: Upon a motion made by Councilman Ferguson and seconded by Councilman Daniels, the Council voted four (4) "ayes" and no (0) "nays" to approve a Request for an Assignment and Assumption of Contract Related to the City's Current Contract and Exclusive Franchise for Collection of Residential Garbage, Refuse, Yard Waste, Bulky Waste, Recyclables, Containerized Waste and Multifamily Recycling with Waste Management of Texas, Inc. to Allied Waste Systems, Inc. The motion carried.

Consideration and Acceptance of an Approximately 14.7601 Acre Tract of Land Adjacent to I 35E, North of Hebron Parkway and South of Lakeway Drive, Being Conveyed to the City of Lewisville by HC LHFI Wilmer, LC; and Authorizing the City Manager, or Her Designee, to Sign Related License and Maintenance Agreements

(Agenda Item H-16)

HC LHFI WILMER, LC, desires to donate four tracts of land to the City (the “Property”). The Property is adjacent to I 35E, north of Hebron Parkway and south of Lakeway Drive. It includes approximately 14.7601 acres of land, and Timber Creek runs through the Property. The owners of the Target Center have agreed to improve and maintain the portion of the Property adjacent to the Target Center. Staff is also currently working on obtaining a license and maintenance agreement with AutoNation to ensure its continued maintenance of the portion of the Property adjacent to its business. Staff needs City Council authorization to sign the license and maintenance agreements and accept the donation of the Property.

The City staff’s recommendation was that the City Council authorize the City Manager, or her designee, to accept donation of the above referenced four tracts of land conditioned on the following for each tract: (1) clean title being provided; and (2) a license and maintenance agreement being signed prior to its acceptance by the City.

Claire Swann, Assistant City Manager, was available to address any questions posed by the City Council.

MOTION: Upon a motion made by Mayor Pro Tem Jones and seconded by Councilman Ferguson, the Council voted five (5) “ayes” and no (0) “nays” to authorize the City Manager, or her designee to accept donation of an approximately 14.7601 acre tract of land adjacent to I35E, north of Hebron Parkway and south of Lakeway Drive, being conveyed to the City of Lewisville by HC LHFI Wilmer, LC; conditioned on the following for each tract: (1) clean title being provided; and (2) a license and maintenance agreement being signed prior to its acceptance by the City; and authorized the City Manager, or her designee, to sign related License and Maintenance Agreements. The motion carried.

Consideration of a Variance to the Lewisville City Code Section 2 201, Fee Schedule, Regarding Waiving Fees Associated with Best Little Brewfest in Texas on October 20, 2018, and Authorizing a Fundraiser Event on City Property, as Requested by Cloud9 Charities

(Agenda Item H-17)

Cloud9 Charities held its first craft beer event, Best Little Brewfest in Texas, in June 2013 as a charity fundraiser. The group moved the event to Old Town Lewisville in 2014. This year's event will be held October 20, 2018, in Old Town Lewisville. Cloud9 Charities is requesting a waiver of special event fees. Similar requests have been approved each year since 2014. Also, per council policy, City Council approval is required for a fundraiser event at a city facility.

The City staff's recommendation was that the City Council approve the fee waiver requested by Cloud9 Charities, and approve the Best Little Brewfest in Texas fundraiser event in Old Town Lewisville on Saturday, Oct. 20.

MOTION: Upon a motion made by Councilman Gilmore and seconded by Deputy Mayor Pro Tem Troyer, the Council voted five (5) "ayes" and no (0) "nays" to approve a variance to the Lewisville City Code Section 2-201, Fee Schedule, Regarding Waiving Fees associated with Best Little Brewfest in Texas on October 20, 2018; and authorizing a fundraiser event on City property, as requested by Cloud9 Charities. The motion carried.







Response Outreach Area Mapper (ROAM)









01 FENCE ELEVATION (RAIL SIDE)


REFERENCE ARCHITECTURAL SITE PLAN FOR SCREENING FENCE LOCATIONS

Old Town Mixed Use 1 Zoning Update

City Council Workshop Session



Background:


- ▶ On October 1, 2018, the City Council considered a zoned change request from R-7.5 (Single-Family Residential District) to OTMU1 (Old Town Mixed Use 1 District) at 411 and 419 Milton Street.
- ▶ Several residents expressed concerns over the impact that the 16 townhomes proposed as part of the zone change request would have on the immediate neighborhood in terms of density, building scale and neighborhood character.
- ▶ Staff also expressed similar concerns and confirmed that the Old Town Master Plan recognized three distinct single-family neighborhoods within the Old Town Design District and recommended that these neighborhoods be preserved.
- ▶ The City Council denied the requested zone change and directed staff to further analyze the OTMU1 District for potential amendments to bring the district in closer alignment with the vision of the Old Town Master Plan.

2003 Old Town Master Plan Recommendations:

- ▶ Old Town neighborhoods should be considered for protection over at least the next five to ten years in the form of conservation areas. These neighborhoods may experience economic pressure for redevelopment depending upon their specific location. Careful consideration should be given to any changes as these neighborhoods provide a stable source of support for area commercial business, offices and facilities.
- ▶ Older residential neighborhoods provide a stable base for Old Town and should be protected and maintained.
- ▶ Existing single-family neighborhoods in Old Town should be protected from expanding commercial development by encouraging single-family infill housing on existing vacant lots.



Recommended Amendments to OTMU1:

1. Remove "Single-family attached dwellings" (townhomes) from use list
2. Remove "Multifamily dwellings" from use list
3. Remove "Private utility plants or sub-stations (SUP)" from use list
4. Remove "Cemetery, columbarium, mausoleum (SUP)" from use list
5. Increase minimum front yard setback from zero to 15 feet, 20 feet for garage doors
6. Add provisions to allow accessory dwelling units (a.k.a. granny flat, garage apartment, pool house, etc.)
7. Revise regulations for institutional and office uses
8. Reduce minimum lot area from 7,500 square feet to 5,000 square feet
9. Reduce minimum primary dwelling unit size from 1,700 square feet to 1,500 square feet.



Proposed Accessory Dwelling Unit Regulations:

Accessory Dwelling Units

- (1) On lots with a minimum of 7,500 square feet, one accessory dwelling unit may be provided.
- (2) No accessory dwelling unit shall exceed the height of the primary dwelling unit or 50% of the area of the primary dwelling unit.
- (3) Minimum accessory dwelling unit size: 500 square feet
- (4) Location on lot: behind or to the side of primary dwelling and setback from side and rear lot lines a minimum of five feet.
- (5) Accessory dwelling units may be leased separately but shall not have a separate tap or meter for water and sanitary sewer.
- (6) Provide parking provisions to minimize increased on-street parking.

Next Steps/Process

- ▶ Option for separate OTMU1 amendment approval (30-60 days)
- ▶ Include with minor Zoning Ordinance/General Development Ordinance update (Spring 2019)
- ▶ Include with Old Town North Overlay (Spring 2019)
- ▶ Development Code Rewrite (18-24 months)
 - ▶ Workshop to discuss project scope planned for November 19
 - ▶ Professional Services Contract coming soon thereafter
